### INTRODUCTION

As I have already mentioed at the postscript of my former handlist of the same kind (A Study of the Modern Scottish Legal Thought : Materials(2), 2, Chūkyō Hōgaku, No.22, vol 1, 1987) , I shall again present a handlist of Scottish books on a social science in my Chukyo University's (or more exactly speaking mainly in my office's) possession, adding newly about five hundred books which I collectted in Scotland during my staying there from September 1987 up to August 1988.

Of course mainly I tried to collect Scots law books which are indispensable to hold in order to research my major theme, Scottish Legal Tradition and Culture. But at the same time, as many as possible, I also tried to collect Scottish books of vorious branches, for example history, philosophy, Scotland in general, and literature etc.,. Because I think that, if we want to understand Scottish Legal Tradition and Culture as a whole and profoundly, we have to know her legal history, history in general, and vorious matters concering her cultural aspects.

Let me give an example. Professor Goldon Donaldson points out as follows : “The Scottish constitution cannot be understood unless the concept of the unchallenged sovereignty of an omniscipotent

parliament is set aside. ” (*Scotland Jams V-James VII*, P.291 ) It means that “there were other bodies (in addition to a parliament) exercising the right of legislation for one aspect or another of the life of the nation ” (P.291) namely royal burghs, the general assembly of the church, and the court of session etc.,.

If it is so, we have to know, for example, at least the history of the general assembly and the Church of Scotland, and the influence of them toward the Scottish people, social life, and present situation of them, etc.,in order to understand the Scottish Legal Tradition and Culure profoundly. Because such Tradition and Culture are composed of and based on the life of the nation which is regulated and greatly influenced by various rules and opinions of the general assembly and the Church (Kirk ! ) of Scotland.

Therefore, I am going to continue to collect Scottish books of various fields as many as possible. And as to such a situation of collecting them, I will report as the form of a handlist of the same kind of this in every few years.

On the occassion of collecting various Scottish books during my staying at Edinburgh, I could get full support from staffs of Faculty of Law at Edinburgh University and many Scottish Second-hand book sellers, particularly from Mr. Spike Hughes. I wish to express my gratitude to them for all their kindness.
